## APPOINTMENT OF VICE CHAIRMAN OF THE BOARD AND THE GROUP'S REGIONAL CHIEF EXECUTIVE OFFICER IN CHINA

The board (“**Board**”) of directors (“**Directors**” and each, a “**Director**”) of Orient Victory Travel Group Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) announces that with effect from 3 December 2018, Mr. Mo Yueming (“**Mr. Mo**”), an executive Director of the Company, was appointed as the Vice Chairman of the Board and the Group’s regional Chief Executive Officer in China, responsible for assisting Mr. Shi Baodong, Chairman of the Board, in formulating the overall development strategy of the listed company and supervising and managing the expansion and daily operation of the Company’s business in the mainland China. The biographical details of Mr. Mo are set out below:

Mr. Mo, aged 53, holds a degree of Executive Master of Business Administration from The HEC School of Management in Paris, France, a Master’s degree in Business in Economics (商業經濟學) from the Chinese Academy of Social Sciences (中國社會科學院) and a Bachelor’s degree in Accounting from Beijing Institute of Business\* (北京商學院).

Mr. Mo has over 20 years of experience in accounting and corporate management of the tourism industry and other industries, including working as the vice general manager and Chief Accountant of China Pan Travel Industry Development Co., Ltd.\* (中國泛旅實業發展股份有限公司) (now known as China Spacesat Co., Ltd. (中國天地衛星股份有限公司) (“**China Spacesat**”), a company listed on the Shanghai Stock Exchange with stock code 600118 and Mr. Mo has been a director of China Spacesat since June 2001; Mr. Mo has been a director of Zhejiang Yongfeng Environmental Sci&tech Co., Ltd. (浙江永峰環保科技股份有限公司) (“**Zhejiang Yongfeng**”), a company listed on National Equities Exchange and Quotations with stock code 838806 since 23 February 2016 for a term from 23 February 2016 to 22 February 2019; and the senior vice president of Orient Landscape Holdings Co., Ltd.\* (東方園林股份分公司) and the Chief Operating Officer of Orient Brigade Group\* (東方文旅集團) from 28 April 2017 to 27 November 2017.

Mr. Mo currently serves as a co-vice Chairman of Orient Victory Group\* (東勝集團) and president of Orient Victory Culture & Travel Group (東勝文化旅遊集團), companies of which controlled by Mr. Shi Baodong, the chairman of the Company. Mr. Mo has been a director of China Comfort Tourism Group Company Ltd.\* (中國康輝旅遊集團有限公司) (formerly known as China Comfort Travel Group Company Ltd.\* (中國康輝旅行社集團有限責任公司)) (“**China Comfort**”), an associate of the Group, since April 2018. Besides, he is also the president of Comfort Cultural Tourism Industry Group Co., Ltd.\* (康輝文化旅遊產業集團股份有限公司) since March 2018.

Mr. Mo has not entered into any service contract with any member of the Group. There is no agreement between the Company and Mr. Mo in respect of the proposed length of service or prior notice to be given by either party for termination of service with regard to his engagement as an executive Director. His term of office shall be subject to retirement by rotation and re-election at least once every three years and in accordance with the memorandum and articles of association of the Company. Currently, Mr. Mo is not entitled to any remuneration (including any director's fee). However, in due course, the Board will determine his remuneration with reference to the recommendation of the remuneration committee of the Company considering his qualification and experience, responsibilities to be undertaken, and the prevailing market level of remuneration of similar position.

To the best knowledge of the Directors, and save as disclosed above, (i) Mr. Mo has not held any other directorships in any public companies the securities of which are listed on any securities market in Hong Kong or overseas in the past three years; (ii) Mr. Mo has not held any other positions in the Company and other members of the Company's group; and (iii) Mr. Mo does not have any relationship with any Directors, senior management, substantial shareholders or controlling shareholders of the Company.

As at the date of this announcement, Mr. Mo does not have, and is not deemed to have, any interests in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

Save as disclosed above, Mr. Mo has confirmed that there are no other matters that need to be brought to the attention of shareholders in connection with his appointment and there is no other information that should be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.
