In the future, when the Company publishes any Corporate Communication on the Websites, it will only send to you a notification that the Corporate Communication has been made available on the Websites. The notification will be sent to you by email (if you have provided a <u>valid</u> email address) or by post (if you have not provided an email address or the email address is <u>invalid</u>) at your address as it appears in the Company's register of members maintained by the Hong Kong Share Registrar.
